



CLUB RULES AND POLICIES



General Rules

1. Anyone entering the facility must be a member (or family of member) of the Hit Machine Baseball, LLC (HMB) unless prior specific authorization is granted.
2. Helmets must be worn by all hitters entering the batting cages.
3. Anyone throwing batting practice and/or pitching to batters must situate themselves behind a protective L-screen.
4. Anyone participating in batting cage/pitching activity releases the HMB from any and all liability that results from their actions, the actions of any other persons in the facility, or their use of the equipment or facility.
5. A maximum of two people are allowed in any batting station at any time. These two people would be (a) a batter wearing a batting helmet and (b) a pitcher (live or machine feed) throwing behind the protective L screen.
6. HMB is a membership based facility. Please be considerate of other members waiting to use the facility by rotating after 30 minutes when others are waiting. Individuals must allow time to facilitate your cleanup of the area and return the machines/area to its original state. ALL balls MUST be picked up and put away after use.
7. ALL members are required to use their fob or key card to sign in and sign out on EVERY visit.
8. Machines are not to be opened or fixed under any circumstances by anyone other than HMB representatives or authorized persons unless specifically allowed by HMB. Anyone touching any machines without prior specific authorization from HMB shall be liable for any resulting damage to the machine, facility, or persons. Members are allowed to adjust speed/height. Must test prior to batter stepping into box. Must be 16 to use machines, unless adult supervised.
9. No person may enter or participate in any activity in or upon the training area without first having submitted a signed wavier on a form approved by HMB.
10. HMB is not responsible for lost or misplaced personal property. Please keep track of your equipment and belongings. Please use bat bag hooks to keep facility orderly and reduce tripping hazards.
11. Must be 16 and above to enter facility without adult supervision.

Food or Drink

1. Please keep all food and water off the turf and in the family seating area, due to potential damage to artificial turf. No exceptions.
2. No gum or sunflower seeds may be chewed while in the HMB facility
3. No cigarettes or other tobacco products may be brought into the HMB facility

Footwear

1. Sneakers and turf shoes are the only footwear items permitted in the training area. No metal or molded cleats are allowed. Each person violating this rule shall be responsible for all resultant damage.

Behavior

1. No person shall pull, hang onto or harm any of the netting in the batting cages and/or surrounding the training area.
2. Horseplay or inappropriate behavior is not tolerated and may result in expulsion from HMB. In such event any fees paid to HMB are forfeited by the offending member.
3. Security Cameras are active and located throughout the facility. Membership agreement is acknowledgement of their use.
4. No SPITTING is permitted within the indoor portion of HMB.
5. No pine tar is to be used inside the facility.
6. Place trash in appropriate receptacles.
7. Respect the facility. We built this for you! Leave things better than you found them!! Please report any issues to Shane/ Dave or the instructors.
